- 1. Covering Letter of Application
- 2. 1-Year Development Plan for the State
- * Once the above documents have been submitted and approved, the State **Grappling** Association will be granted a 1-Year Provisional Affiliation from **GFI** & **State** Association must submit below documents within 2 months from yours Provisional Membership. If you fail to do same then GFI have right to cancel yours **Provisional Membership**.
 - 1. Certificates of Registration under Charity Commissioner, Society, Company & Trust Act.
 - 2. Bye Laws of the Society, Names & Addresses of the Office Bearers & other relevant details.
- * The Provisional Affiliation will empower the State **Grappling** Association to carry out **Grappling** development activities within their region, under the guidelines of **GFI** mentioned below...
 - To introduce Grappling in Schools / Clubs, for both boys and girls, within the State
 - To conduct at least 1 Training Camp for Coaches, under the supervision of GFI representatives
 in the first 3 months of being granted provisional affiliation
 - To conduct at least 1 Training Camp for Players, under the supervision of GFI representatives –
 in the first 3 months of being granted provisional affiliation
 - To conduct at least 1 Training Camps for Referees, under the supervision of GFI representatives in the first 3 months of being granted provisional affiliation

On the basis of the 1-year performance review, the Provisional Affiliation will be extended. However, in the event that the State **Grappling** Association fails to comply with the **GFI** guidelines, their Provisional Affiliation may be suspended and/or cancelled.
