- The election in the event contest shall be through secret ballot only.
- Every member of the AFFILIATED STATE UNIT OF GFI who is in the good standing in accordance of Memorandum of Association and Bye laws of **GRAPPLING FEDERATION OF INDIA**, enlisted in the Electoral College to participate in the elections. State -02 (Two); Union Territory-02 (Two), representative each shall be entitled.
- Representatives should carry necessary identity card such as **Aadhar card** indicating the belongingness from the concerned Districts. Based on the same, Entry-card for **GFI** Elections will be issued.
