Sub – Conduct of National Level Selection Trial for the Participation of GFI National Team in the UWW World Grappling Championship-2022.

Respected Sir/Madam,

We feel it graceful to inform you that Grappling Federation of India is going to conduct National Level Selection trial for the participation of GFI National Team in the **UWW World Grappling Championship-2022** at Belgrade (Serbia) from 05th – 08th September 2022 in which 30 countries & around 500 participants are expected to participate in Gi & No-Gi Disciplines. GFI has Invited registration for National Level athletes to participate in the National Level Selection Trial, and as per the entries received for the participation in above mentioned UWW World Championship, GFI is going to conduct the National Level Selection trial for the above mentioned Events on the following Venues & as per the following Schedule.

As per the GFI Eligibility Criteria athletes who have registered to participate in the National Level Selection Trial has to strictly follow the guidelines as under:-

Following Original documents must be submitted by the participants at the Venue of the Selection trial for physical verification :

1. After the successful registration on the GFI website participant needs to bring the print out copy of the GFI Online Registration Form of the Selection Trial along with online payment proof of Selection trial registration fees.

2. Original Participation/Merit Certificate of 14th GFI National Grappling Championship-2021 Organized by GFI.
3. Original Passport is mandatory for participating in the said selection trial. Hence all participants are advised to bring the same.
4. A participant has to bring their Aadhar ID card & keep it handy throughout the Trial duration.
5. Participants are required to fill up & submit the below given Performa regarding the KIT Size/Measurement to enable GFI to arrange the sports gear well in advance for the selected team.

Important Instructions:

1. Participant must reach the venue on the reporting date & time as mentioned above, if he/she fails to reach on the reporting date & time he/she is not liable to claim his/her participation in the said selection trial.
2. If the original documents are found incomplete/incorrect/tempered, the GFI has right to disqualify the said participant.
3. Once the Athlete is selected to participate in the above said Event he/she has to follow the guidelines & instructions prescribed by UWW/GFI to submit the documents & the expenditure, failing which the waiting list athletes will be considered for the participation.
4. The Decision of the Technical Committee & Selection Committee will be final & No athlete can claim & challenge legally his/her selection on any grounds which are not obvious to the technical/selection committee.
5. The Qualification parameter for each Event will be decided by the technical/selection committee.
6. If the athletes fail to Qualify the parameters decided by the technical/selection committee then he/she will not be able to claim his/her participation & no further chance will be given. The decision of technical/selection committee will be considered as final.
7. In case of No participation in any of the events then GFI may drop the event as per rules & regulations of UWW.
8. In case of any illness or medical fitness of the selected athletes, the waiting list athlete of the respective event will be considered for the participation.
9. UWW Medical Certificate is required for participation in this event.
10. UWW 2022 Athlete Licence is mandatory to participate in this event.
11. GFI National Licence is mandatory to participate in this event.
12. The expenditure for the participation in Event (Boarding, Lodging, UWW Licence & Transportation) has to be borne by the respective States/UT 's/Unit/Club/Sponsors/Participant.

Boarding, Lodging & Transportation

- Considering the Covid-19 Protocol Boarding, Lodging & Transportation has to be borne by the respective athlete/participant as per their convenience.
- They may also Opt Boarding & Lodging facilities in the Campus premises on chargeable basis.

Note --:

1. The expenditure for the participation in Selection Trial (Boarding, Lodging & Transportation) has to be borne by the respective States/UT 's/Unit/Club/Sponsors/Participant.
2. The entire expenditure of the Selected Athlete for the participation in the UWW World Championship has to be borne by the respective States/UT's/Unit/Schools/ Sponsors/Participant.
3. COVID-19 Protocol must be strictly followed as per Govt. of India Guidelines.

4. Participant may bring COVID-19 Vaccination certificate along with other supporting documents.
